PETITION

The petition of the STATE OF LOUISIANA, DEPARTMENT OF TRANSPORTATION & DEVELOPMENT, ("Petitioner"), legal successor to the Department of Highways, created and organized under the laws of the State of Louisiana, with its domicile in the City of Baton Rouge, Parish of East Baton Rouge, State of Louisiana, with respect, represents that:

1.

MCLAIN INVESTMENTS, L.L.C. and JORDAN LEWIS are the defendants herein ("Defendants").

2.

The STATE OF LOUISIANA, DEPARTMENT OF TRANSPORTATION & DEVELOPMENT, proposes to construct in the Parish of Iberia, a certain project designated as State Project No. H.010922, LA 88: Realign Curves in Coteau, State Route LA 88, which project is more fully described by a Certificate of Authorization to Expropriate, approved by the Secretary of the Department of Transportation & Development on September 17, 2021, which declares that it is necessary and useful to take immediately the hereinafter described property for highway purposes, a certified copy of said Certificate of Authorization to Expropriate being marked "Exhibit P-1," attached hereto and made a part hereof.

3.

The construction of said project will be greatly conducive to public interest, convenience and safety, and will be an important improvement to the State Highway System.

4.

Petitioner has surveyed the right of way and laid out the centerline thereof for said project as the same will exist after said project is completed, and the width of the right of way has been fixed by the Chief Engineer of the Department of Transportation & Development, as shown by the Certificate of the Chief Engineer marked "Exhibit P-2," annexed hereto and made a part hereof.

Included within the right of way required for said project is certain property believed to be owned by Defendant, MCLAIN ENTERPRISES, L.L.C., subject to a lease in favor of JORDAN LEWIS, a portion of which is required in full ownership designated as Parcel Nos.3-1 and 3-2, and a portion of which is required for a permanent servitude of drainage designated as Parcel Nos. 11-1-D-1 and 11-3-D-1, and described as follows, to-wit:

Four (4) certain tracts or parcels of land, and all of the rights, ways, privileges, servitudes and advantages thereunto belonging or in anywise appertaining, situated in the Parish of Iberia, State of Louisiana, and in Sections 25 and 36, Township 11 South, Range 5 East, Southwestern Land District, identified as Parcel Nos. 3-1, 3-2, 11-1-D-1 and 11-3-D-1, on a white print of a plat of survey, consisting of Sheet Nos. 3, 11 and 12, made by Randall E. Ward, Registered Land Surveyor, dated May 8, 2020, revised, annexed to the above numbered and entitled suit, said tracts or parcels being outlined in red and being more particularly described in accordance with said plat of survey, as follows:

REQUIRED IN FULL OWNERSHIP

From a point on the centerline of State Project No. H.010922 (LA 88), at Highway Survey Station 112+21.66, which is the point of beginning, proceed N00°57'32"E a distance of 87.08 feet to a point and corner, thence proceed along a curve to the right having a radius of 2585.00 feet, whose length is 153.83 feet and whose chord length is 153.81 feet and bears S74°59'28"E to a point and corner; thence proceed N73°26'40"E a distance of 87.01 feet to a point and corner; thence proceed N30°22'08"E a distance of 160.92 feet to a point and corner; thence proceed N40°23'06"E a distance of 102.66 feet to a point and corner; thence proceed S24°18'43"W a distance of 199.12 feet to a point and corner; thence proceed along a curve to the right having a radius of 630.00 feet, whose length is 253.72 feet and whose chord length is 252.01 feet and bears S35°50'58"W to a point and corner; thence proceed S47°23'12"W a distance of 56.88 feet to a point and corner; thence proceed N26°07'00"W a distance of 35.77 feet to a point and corner; thence proceed along a curve to the left having a radius of 2425.00 feet, whose length is 98.92 feet and whose chord length is 98.91 feet and bears N74°41'55"W to a point and corner; thence proceed N00°57'32"E a distance of 76.96 feet to the point of beginning. All of which comprises Parcel 3-1 as shown on Sheet 3 of the Right of Way Plans of State Project No. H.010922 (LA 88), and contains an area of approximately 43572.8 square feet or 1.000 acres.

From a point on the centerline of State Project No. H.010922 (LA 88), at Highway Survey Station 114+65.47, which is the point of beginning, proceed along a curve to the left having a radius of 670.00 feet, whose length is 190.84 feet and whose chord length is 190.20 feet and bears N32°28'19"E to a point and corner; thence proceed N24°18'43"E a distance of 199.88 feet to a point and corner; thence proceed S07°00'35"W a distance of 106.12 feet to a point and corner; thence proceed S23°17'30"W a distance of 163.61 feet to a point and corner; thence proceed S24°45'42"E a distance of 62.68 feet to a point

and corner; thence proceed along a curve to the right having a radius of 2575 feet, whose length is 40.10 feet and whose chord length is 40.10 feet and bears S67°39'46"E to a point and corner; thence proceed S58°57'58"W a distance of 384.29 to a point and corner; thence proceed along a curve to the right having a radius of 605.00 feet, whose length is 18.54 feet and whose chord length is 18.54 feet and bears N26°02'52"E to a point and corner; thence proceed N26°55'33"E a distance of 44.92 feet to a point and corner; thence proceed N47°23'12"E a distance of 103.05 feet to a point and corner; thence proceed along a curve to the left having a radius of 670.00 feet, whose length is 78.99 feet and whose chord length is 78.94 feet and bears N44°00'34"E to the point of beginning. All of which comprises Parcel 3-2 as shown on Sheet 3 of the Right of Way Plans of State Project No. H.010922 (LA 88), and contains an area of approximately 30910.1 square feet or 0.710 acres.

REQUIRED FOR A PERMANENT SERVITUDE:

PARCEL NO. 11-1-D-1:

From a point on the centerline of State Project No. H.010922 (PROPOSED DITCH), at Highway Survey Station 0+85.86, which is the point of beginning, proceed N47°23'12"E a distance of 18.72 feet to a point and corner; thence proceed S71°17'55"E a distance of 21.11 feet to a point and corner; thence proceed S58°57'58"W a distance of 70.80 feet to a point and corner; thence proceed N28°55'49"W a distance of 4.43 feet to a point and corner; thence proceed N47°23'12"E a distance of 39.46 feet to the point of beginning. All of which comprises Parcel 11-1-D-1 as shown on Sheet 11 of the Right of Way Plans of State Project No. H.010922 (PROPOSED DITCH), and contains an area of approximately 695.4 square feet or 0.016 acres.

PARCEL NO. 11-3-D-1:

From a point on the centerline of State Project No. H.010922 (PROPOSED DITCH), at Highway Survey Station 0+01.28, which is the point of beginning, proceed S88°53'27"E a distance of 7.11 feet to a point and corner; thence proceed S11°39'44"E a distance of 25.51 feet to a point and corner; thence proceed S47°23'12"W a distance of 32.59 feet to a point and corner; thence proceed N00°57'32"E a distance of 47.41 feet to a point and corner; thence proceed S88°53'27"E a distance of 10.92 feet to the point of beginning. All of which comprises Parcel 11-3-D-1 as shown on Sheets 3 and 11 of the Right of Way Plans of State Project No. H.010922 (PROPOSED DITCH), and contains an area of 784.0 square feet or 0.018 acres.

This property is outlined in red on a plat of survey marked "Exhibit P-3" in globo, annexed hereto and made a part hereof.

The above-described property is owned by MCLAIN INVESTMENTS, L.L.C., subject to a lease in favor of JORDAN LEWIS

8.

This property is a portion of a larger tract believed to be owned by Defendants.

9.

There are no buildings situated wholly or partially upon the above-described property and there are no improvements situated wholly or partially upon the above-described property.

10.

The location and design of the improvements proposed by said project are in accordance with the best modern practices adopted in the interest of the safety and convenience of the traveling public, as shown by the Certificate on Location and Design which is marked "Exhibit P-4," annexed hereto and made a part hereof.

11.

In order to construct said project in a manner and mode conducive to the public interest, convenience and safety, it is necessary that Petitioner acquire in full ownership the property described as Parcel Nos. 3-1 and 3-2, and together with all the rights and interests of the lessee, subject to the mineral reservation set forth below, and a permanent servitude of drainage on, over and across the property described as Parcel Nos.11-1-D-1 and 11-3-D-1, which property Petitioner has attempted to acquire amicably but has been unable to do so.

12.

Therefore, it is necessary for Petitioner to expropriate in full ownership the property described as Parcel Nos. 3-1 and 3-2, and together with all the rights and interests of the lessee, subject to the mineral reservation set forth below, and a permanent servitude of drainage on, over and across the property described as Parcel Nos.11-1-D-1 and 11-3-D-1.

The expropriation of the full ownership of the property described as Parcel Nos. 3-1 and 3-2 shall be made subject to the reservation in favor of the owners, MCLAIN INVESTMENTS, L.L.C. and JORDAN LEWIS, of all oil or gas located under the property described above, or the royalties therefrom, in accordance with law, and subject to any existing oil or gas reservation or to any existing oil or gas lease, such reservation of mineral rights being imprescriptible as authorized by La. R.S. 31:149.

14.

The just compensation to which Defendant is entitled, being the compensation for the full ownership of the property described as Parcel Nos. 3-1 and 3-2, and together with all the rights and interests of the lessee, subject to the mineral reservation set forth herein, and a permanent servitude of drainage on, over and across the property described as Parcel Nos. 11-1-D-1 and 11-3-D-1, has been estimated to be the sum of Fifty-One Thousand Four Hundred Sixty-Eight and 00/100 Dollars (\$51,468.00), as shown by the written Certificates of Estimate of Compensation marked "Exhibit P-5A," "Exhibit P-5B," "Exhibit P-5C" and "Exhibit

P-5D" annexed hereto and made a part hereof.

15.

Petitioner is entitled to expropriate the full ownership of the property described as Parcel Nos. 3-1 and 3-2, and together with all the rights and interests of the lessee, subject to the mineral reservation set forth herein, and a permanent servitude of drainage on, over and across the property described as Parcel Nos. 11-1-D-1 and 11-3-D-1, in a manner authorized by Article 1, Section 4 of the Constitution of the State of Louisiana for the year 1974, and Title 48 of the Louisiana Revised Statutes of 1950, Sections 441 to 460, inclusive as amended and reenacted.

16.

Petitioner is entitled to trial by jury as authorized by Title 48 of the Louisiana Revised Statutes, Section 451.2, as amended and reenacted.

Petitioner desires to utilize the cash deposit authorized by Article 1734.1 of the Louisiana Code of Civil Procedure and desires that the amount of the deposit be fixed as required by law.

18.

Petitioner requests written notice at least thirty (30) days prior thereto of any trial, motion or other proceeding scheduled to come before this Honorable Court in this lawsuit in accordance with Title 48 of the Louisiana Revised Statutes, Section 451, and also requests notice of any interlocutory or final order, decree or judgment rendered and signed in this lawsuit as provided by the Louisiana Code of Civil Procedure.

WHEREFORE, Petitioner prays that an Order issue herein directing Petitioner to deposit in the Registry of this Court the sum of Fifty-One Thousand Four Hundred Sixty-Eight and 00/100 Dollars (\$51,468.00) for payment to the person or persons entitled thereto, and declaring that the full ownership of the property described as Parcel Nos. 3-1 and 3-2, and together with all the rights and interests of the lessee, subject to the mineral reservation set forth herein, and a permanent servitude of drainage on, over and across the property described as Parcel Nos. 11-1-D-1 and 11-3-D-1, has been taken for highway purposes as of the time such deposit is made.

Petitioner further prays that said Order directs Defendants to surrender to Petitioner possession of said property.

Petitioner further prays that the Order of Expropriation in this matter be recorded in the conveyance records of Iberia Parish.

Petitioner further prays that Notice of this expropriation be issued and served upon Defendants, MCLAIN INVESTMENTS, L.L.C. and JORDAN LEWIS, together with a certified copy of this Petition, the Order of Expropriation of this Court, and the Receipt of the Clerk of Court for the deposit made, according to law.

Petitioner further prays that this matter be tried by jury and that it be allowed to utilize the cash deposit authorized by La. C.C.P. art. 1734.1.

Petitioner further prays that it be served with written notice of any trial, motion or other proceeding scheduled before this Honorable Court in accordance with La. R.S. 48:451, and that it be served with notice of any interlocutory or final order, decree or judgment rendered and signed as

provided by the Louisiana Code of Civil Procedure.

Petitioner further prays that upon a final hearing there be judgment herein in favor of Petitioner fixing the amount of just compensation at a sum not to exceed Fifty-One Thousand Four Hundred Sixty-Eight and 00/100 Dollars (\$51,468.00).

The Department of Transportation and Development contemplates and plans to construct certain projects for the improvement of various highways throughout the State of Louisiana.

The project presently planned by the Department of Transportation and Development is hereinafter set forth:

STATE PROJECT NO. H.010922 LA 88: REALIGN CURVES IN COTEAU ROUTE LA 88 IBERIA PARISH

State Project Number H.010922 provides for grading, earthwork, drainage structures, base course, asphalt concrete pavement and striping on LA 88 in Iberia Parish, as follows:

Beginning LA 88 at approximate Highway Survey Station 98+40.00, then proceed in a easterly direction to end at approximate Highway Survey Station 150+42.56.

Beginning Fremin Rd. Ext. at approximate Highway Survey Station 202+50.00, then proceed in a northerly direction to end at approximate Highway Survey Station 214+46.00.

Beginning East Connector at approximate Highway Survey Station 295+66.63, then proceed in a northerly direction to end at approximate Highway Survey Station 307+28.12.

The total roadway length is approximately 1.432 miles, for an overall project length of approximately 1.432 miles.




