Is third time the charm for tax swap for infrastructure dollars proposal?

A bipartisan group of lawmakers is planning to try for the third time in three years to pass a bill that would allow manufacturers to pay an upfront set fee to local taxing authorities in lieu of their property taxes.

The payments instead of ad valorem taxes, or PILOT, would allow local governments to receive money early that can then be spent on roads, bridges, schools and other infrastructure needs.

"Basically, industry and local government representatives negotiate a deal for a period of years that would give industry a bigger break than they would receive from the Industrial Tax Exemption Program and give local government an income stream right away for whatever they want," says lobbyist Tom Spradley, who is working on the bill with several legislators.

Spradley says it's still unclear who will sponsor the bill and how the final language will read, but he expects the finished product to closely resemble a bill last year sponsored by Rep. Alan Seabaugh, R-Shreveport.

That bill passed in the House but was defeated in a Senate committee, largely because of concerns from assessors around the state. They argued the bill would allow each taxing district in a parish—of which there can be dozens—to cut its own deal with a manufacturer, thereby causing confusion and chaos. Together Louisiana also opposed the bill arguing that, much like the Industrial Tax Exemption Program, it amounts to "corporate welfare."

But conservative advocates of the bill, who were joined in their support for the idea by Democratic Gov. John Bel Edwards, say PILOT represents a proverbial win-win, giving industry a fair, predictable liability that can be paid up front to a community,

while also giving school boards, parish councils and other local governmental entities badly needed revenues in a state that has little money for capital expenditures.

"Local government gets an income stream from year one that hopefully creates an economic impact factor," Spradley says. "We think this is a really progressive thing to do."

As currently envisioned, the proposed legislation would include two measures: a Constitutional amendment that would have to be approved by voters and a simple statute giving local governments that authority to enter into such deals with manufacturers.

Spradley says lawmakers will plan to introduce the measures in the Senate first this year, since the House has already indicated broad support for the program.

Louisiana winners—and possible losers—in the aftermath of GOP-led tax reform

Local accountants and CPAs didn't get much of a break over the recent holiday. They were scurrying to make sense of the \$1.5 trillion tax reform package signed into law by President Donald Trump just days before Christmas.

While there are still a lot of unanswered questions about the tax package and what its implications will be long term, the consensus for now is that Louisiana, in general, will benefit in the short term.

For one, the plan will allow Louisiana victims of the 2016 floods to amend their tax returns for that year to deduct flood-associated losses, which some estimate could bring as much as \$500 million to the state.

The law also waives a 10% penalty for flood victims who withdrew money from their 401(k) s to pay for flood damage.

Another provision is expected to increase offshore oil revenue for Gulf States through the Gulf of Mexico Energy Security Act. That could bring another \$100 million to Louisiana.

Still another victory is the retention of the historic building tax credit program. Louisiana is one of the country's biggest users of the program, which incentivizes developers to return historic buildings to commerce by reimbursing them for up to 25% of their cost, and it was spared thanks mainly to efforts of Louisiana's congressional delegation.

Finally, Louisiana's booming petrochemical industry, like big business and industry around the country, will reap the benefits from a permanent reduction in the corporate tax rate, which has been slashed from 35% to 21%.

For the state's many small businesses, the benefits of the legislation are not as clear cut, though most pass-through businesses—sole proprietorships, partnerships and S corporations—will receive a 20% tax deduction on their taxable income, which, it is hoped, will allow business owners to reinvest that saved money back into their businesses.

While many Louisiana taxpayers will see a reduction this year in their personal income tax bill, experts say effects of the changes will vary depending on a family's size, income and which deductions they are eligible to take. Also, the personal income tax reductions are set to expire in 2025, unlike corporate income tax cuts, which are permanent.

Among the potential losers in Louisiana is LSU. A provision in the law repealing charitable donations for season ticket holders of university sports programs could adversely impact college sports.

The nonprofit sector is also concerned about several changes to the tax law that threaten charitable giving. Among them: Decreased tax rates will mean donations will be worth less in tax benefits when donors write them off on their returns; a rollback of the estate tax makes estate giving less enticing financially; and, perhaps most troubling, the plan nearly doubles the standard deduction, which is expected to dramatically reduce the number of people who itemize—or write off—specific, eligible expenses, including charitable gifts.

What that will mean for the nonprofit sector long term remains to be seen. Those provisions, like others in the law, are still being scrutinized by experts, who say it will be a while before they understand the full impact of the package on Louisiana and the nation as a whole.



Who Does an Accident Hurt?

According to OSHA (Occupational Safety and Health Administration), construction is one of the most hazardous industries. If an accident happens, the mindset of some is that, as bad that it is that someone got hurt, it doesn't affect them. What they don't consider is that accidents don't just affect people who are directly hurt. Indirectly, accidents affect everyone involved, in one way or another. Imagine this scenario.

An accident happens on a work site. At the onset the injury seems worse than it is. Immediately, for a few moments, work on the job site stops to allow the injured to be attended to. This impairs the schedule and causes delay. Thus at this point the entire job is being affected.

Meanwhile, reports of the accident reach the public, and the company's office is flooded with calls inquiring about the accident. Those calls tie up company phone lines, interrupting everyone's work, delaying progress, and delaying the company's ability to correct the problem that caused the accident.

Following the accident some or all of the following will occur for the injured; pain, discomfort, disability, loss of earnings, loss of the ability to continue in his craft, total disability or even death.

Let's consider family, maybe a wife and children. Do any of the above possibilities affect them? What about a parent or brother or sister? Friends even enter into the equations.

Now, let's consider the foreman on the job. He is responsible for making sure a certain amount of work is completed by his crew. Anything that injures or delays one of his men, or interrupts the orderly flow of the job, reflects unfavorably on his ability to control and direct the work for which he is responsible. Will an accident affect him?

Suppose we consider the superintendent next. He is responsible for completing an assignment by a designated date at an agreed upon price. Anything that injures a worker or delays the project and interrupts the orderly accomplishment of the job reflects unfavorably on his ability to control and direct the work for which he is responsible. An accident will certainly affect him.

What about the loss suffered by the company? Each accident that occurs on a job reflects their ability to attract skilled workers needed to fulfill a contract. The reputation of the company is hurt by its failure to prevent accidents.

Last, don't forget the customer, in the form of a delayed contract, additional insurance costs and their ability to get their product to the market.

All of the above is why the construction industry takes safety programs seriously. Safety programs are in place not only for you as an individual, but for everyone involved.
