SUBJECT: BRIDGE DESIGN TECHNICAL MEMORANDUM NO. 105 (BDTM.105) -PUBLICATION OF NEW STANDARD PLANS – MISC. SPAN DETAILS

DATE: July 1, 2021

Effective immediately, use the new Misc. Span Details Standard Plan with Chief Engineer signature date of May 12, 2021 for all projects with a letting date of January 12, 2022 and beyond. The Standard Plan has been published to the Department Standard Plans website and to ProjectWise.

The new Misc. Span Details Standard Plan is the result of converting the recent Misc. Span Details Special Details in accordance with EDSM I.1.1.2.

Noteworthy updates in the new Misc. Span Details include the following:

- 1. Notes have been updated.
- 2. Sections showing deck drains have been updated to show the 36-in single slope barrier.
- 3. The 36-in single slope barrier case has been added to the sealed expansion joint details.
- 4. The plan view showing the layout of the joint in skewed bridges for both sealed expansion joints has been updated to reflect joint skew limits between the two exterior girders instead of the two gutter lines as has historically been the case.
- 5. Preformed silicone seal detail has been differentiated for prestressed precast concrete girder and steel girder bridges.
- 6. End dam stabilizer detail for preformed silicone joints has been differentiated for prestressed precast concrete girder and steel girder bridges.
