## US plans new safety rules to crack down on carbon monoxide poisoning from portable generators

The U.S. agency responsible for protecting consumers announced this week that it intends to recommend new mandatory rules to make portable generators safer, saying manufacturers have not voluntarily done enough to prevent carbon monoxide poisoning deaths caused by their products.

The announcement, part of a 104-page staff report by the Consumer Product Safety Commission, is a key step toward regulating gas-powered generators, which can emit as much carbon monoxide as 450 cars and which kill an average of 80 people in the U.S. each year.

The commission's move comes more than two decades after U.S. regulators identified the deadly risks posed by portable generators and two months after an NBC News, ProPublica and Texas Tribune investigation found that federal efforts to make portable generators safer have been stymied by a statutory process that empowers manufacturers to regulate themselves, resulting in limited safety upgrades and continued deaths.

Portable generators, which are often used to power life-saving medical equipment, air conditioners, furnaces and refrigerators after major storms, emit enough carbon monoxide to kill within minutes when operated in enclosed spaces or too close to exterior openings. Carbon monoxide deaths caused by generators occur after nearly every major power outage, including 10 fatalities in Texas tied to generators during last year's winter storm and power grid failure.

Generator manufacturers say that their products are not dangerous when users follow the safety guidelines in instruction manuals, which include keeping the machines outside, away from doors and windows. But safety advocates say

those instructions aren't always easy to follow, because the machines can't be operated in rain or snow. And a review of user manuals by the news organizations found that they can provide conflicting messages. Some manuals suggest keeping generators a shorter distance from windows or doors than the 20-foot minimum recommended by the CPSC, while others provide more general guidance such as keeping the machines "far away" from homes.

The new push for mandatory rules has been years in the making. In 2016, after concluding that generator manufacturers could save lives by making machines that emit less carbon monoxide, the CPSC announced plans to make the modification mandatory.

But before the CPSC could impose the rule, industry-friendly federal law required the agency to first allow generator manufacturers to come up with their own safety upgrades and to study whether those voluntary measures were enough to protect consumers.

Industry representatives instead proposed a cheaper safety upgrade: switches that would automatically turn the devices off when carbon monoxide builds up to an unsafe level. They said the shut-off switches would prevent 99 percent of deaths, but safety advocates argued that claim was exaggerated.

Three years after the industry unveiled the voluntary standard, many manufacturers still had not adopted the change, the NBC News, ProPublica and Texas Tribune investigation found. This week's CPSC report echoed those findings. The commission found that too few manufacturers had adopted voluntary changes, clearing the way for it to continue the process of developing and implementing mandatory regulations.

"Think how many lives could have been saved had the CPSC gone forward with a mandatory standard in 2016," said Marietta S. Robinson, who served as a CPSC commissioner from 2013 to 2018

and supported mandatory generator safety standards.

The CPSC report concluded that voluntary changes implemented by some manufacturers did reduce the risk to consumers, but not to the degree that industry officials had promised.

Based on tens of thousands of simulations of common generator carbon monoxide accidents, CPSC staffers found that the industry's preferred solution of adding shut-off sensors without reducing carbon monoxide emissions would prevent about 87 percent of generator deaths, while still leaving some consumers exposed to CO levels toxic enough to require hospitalization.

CPSC staffers also tested a more stringent approach of equipping the machines with both shut-off sensors and engines that emit far less carbon monoxide, and found that the combination would eliminate "nearly 100 percent" of generator deaths and the vast majority of hospitalizations.

The agency's staff will urge the CPSC's five commissioners, who have the final say, to make the recommended mandatory standard a priority in the next fiscal year, which begins in October.

Alex Hoehn-Saric, the group's newly appointed chair, said in a statement that the new CPSC staff report on portable generators "demonstrates the need to move forward as quickly as the law permits with mandatory rulemaking designed to address this invisible killer."

A ProPublica, Tribune and NBC News analysis of CPSC data showed that more than 300 people died from carbon monoxide poisoning from generators in the four years after CPSC proposed its rule lowering emissions.

"It's about time," said Sheletta Brundidge, a Houston native who lost five family members in 2020 when they left a portable generator running inside an attached garage after Hurricane Laura knocked out power across Louisiana. "You

can't expect these companies to police themselves. And, you know, I gladly and I'm sure most Americans would pay some additional money to have some safety measures in place."

The CPSC previously estimated that reducing generators' carbon monoxide emissions would add about \$115 to the manufacturing cost of most units, which typically sell for \$500 to \$1,500.

Joseph Harding, technical director at the Portable Generator Manufacturers' Association, the trade group that developed the voluntary shut-off switches standard, said in an email that the group was still in the process of reviewing the CPSC's report. Harding reiterated the industry's belief that shut-off switches alone would eliminate 99 percent of deaths from carbon monoxide poisoning, and disputed the agency's conclusion that too few companies had adopted the safety measure.

"Compliance with the standard is already at a high level and is projected to grow substantially in the next year," Harding wrote. The industry group declined to provide data supporting that contention to the news organizations, saying it was confidential.

Rachel Weintraub, general counsel for the advocacy group Consumer Federation of America, said this moves the CPSC closer to establishing a mandatory standard for portable generators.

The lack of widespread compliance, she said, provides the CPSC with direct evidence that refutes the industry's claims that voluntary measures are enough to protect consumers. "There are less levers that they can pull to slow the process," Weintraub said, referring to the industry.

Brundidge said she hopes the latest effort to mandate safety upgrades moves more quickly.

"It shouldn't have taken all of these people to die and get sick for somebody to come and say, 'Hey, wait a minute, we need to do something,'" she said. "And so I'm glad that finally something is being done to police the manufacturers, because we've

been putting it on the consumers, and that's not right."

## Health Care firms were pushed to confront racism. Now some are investing in Black startups.

(Special from Nashville Public Radio via [khn.org](http://khn.org)) — Marcus Whitney stands out in Nashville's \$95 billion health care sector as an investor in startups. In addition to co-founding a venture capital firm, he's organized an annual health tech conference and co-founded the city's professional soccer club. And, often, he's the only Black man in the room.

So in summer 2020, as Black Lives Matter protesters filled city streets around the country following George Floyd's murder, Whitney pondered the racial inequalities that are so obvious in his industry — especially locally.

"I sat at the intersection of two communities — one that I was born into and one that I had matriculated into," he said.

On a quiet Sunday morning after the protests died down, he pounded out a long letter to his peers that pointed out those making the most money from Nashville's for-profit health care industry are still almost all white men.

Whitney hit publish on Monday, leading to weeks of intense conversations.

The racial reckoning of the past couple of years has inspired many

industries to take a look at their histories and practices. In health care, there are long-standing and well-documented disparities in care for Black and white patients.

Those disparities have carried over into who gets funding for research and health startups. Of the nation's more than 900,000 health care and social assistance companies, which include home health and other health services, roughly 35,000 — or fewer than four percent — are Black-owned, according to data from the U.S. Census Bureau.

Whitney wrote that this problem isn't his to fix, but he realized he's in a unique position as one of the few Black venture capitalists in health care. So his firm, Jumpstart Foundry, launched a dedicated fund to get behind Black entrepreneurs in health care. The letter was "pretty key" to pulling in investors, he said.

The fund is called Jumpstart Nova. It's a tiny slice of the estimated \$42 billion of venture funding invested last year in health tech. But it did exceed its initial goal, raising \$55 million from the likes of pharmaceutical giant Eli Lilly, medical supplier Cardinal Health, and the hospital chain that started Nashville's health care industry, HCA.

Each corporation measures its annual profits in the billions of dollars, so the fund represents only a sliver of their investments. But Jumpstart is also just one part of their broader diversity investment initiatives. For example, Indianapolis-based Eli Lilly has committed \$92 million to Black-led venture capital firms since December 2020, according to company spokesperson Carrie Martin Munk.


Whitney said he didn't have to convince those blue-chip firms that investing in Black founders was a wise move, but he did have to make the case that they would have enough promising startups from which to choose.

"That was really emblematic of the fact that there was a disconnect between the communities. These investors simply did not know enough Black people to know whether or not there were enough deals out there," Whitney said. "This is not like an indictment of them. This is the reality of our country."


Jumpstart Nova is the lead investor in three of the four companies it's working with so far. That means Whitney's team scrutinizes the business plan, vouches

# Orleans Parish school board member John Brown Sr. resigns

Orleans Parish School Board member John Brown Sr. announced that he was resigning from the board after learning his daughter is among a group of candidates being considered to replace outgoing NOLA Public Schools Superintendent Henderson Lewis Jr.

In a statement, Brown said he was taking the step of resigning to avoid a conflict of interest because the board is guiding the search process — along with a contracted search firm — and members will ultimately have to vote on Lewis' replacement.

"I have been informed by my daughter, Dr. Jawan Brown-Alexander, that her application for superintendent was recommended by the search firm assisting OPSB to move on to the interview phase of the superintendent search," Brown said in the emailed statement.

"While I had previously recused myself from the process and have been advised that I could continue to do so, I personally believe that as my daughter is now a formal candidate for the superintendency of our schools, it is now only appropriate that I step aside from my position."

The retired 30-year educator

has represented District 1, covering a large portion of New Orleans East and the Lower 9th Ward, since he was appointed to

take over the vacant position in 2015, replacing Ira Thomas, who resigned after being charged in a bribery scheme. Brown won the

seat in the 2016 election and was reelected in 2020.

The board's search for a superintendent has been underway since Lewis announced in June that the 2021-22 school year would be his last.

Last week, the board held a special meeting to learn about candidates from the search firm. Brown did not attend. The board voted to invite "one or more" candidates for an interview but did not name any of the recommended candidates.

"I have dedicated my entire adult life to my family, community, and the youth of New Orleans," Brown said in the

statement. "It has been a great honor to work on behalf of our young people as a teacher, coach, principal, mentor, and education leader."

Brown served as board chair for three consecutive years.

"Serving on the Orleans Parish School Board has been an incredible milestone in my service and I am so proud of many things we accomplished together, including during my time as School Board President."

## Louisiana museum in Baton Rouge plans: Professor Longhair's life, legacy exhibit

(AP) — An exhibit about the life and legacy of the New Orleans pianist known as Professor Longhair will open next month at a state museum near the Louisiana state Capitol.

Henry Roeland Byrd was a great influence on New Orleans music. His hits include "Tipitina," "Mardi Gras in New Orleans," and "Big Chief."

"Professor Longhair was the baddest," said David Kunian, curator of the exhibit opening April 19 at the Capitol Park Museum, said in a news release from the Department of Culture, Recreation and Tourism. "All pianists in New Orleans and beyond bowed down to his feet, worshipped at his altar, smoked his peace pipe, ate his gumbo, and saw

his Zulu Queen on Rampart and Dumaine."

The exhibit, running through Aug. 6, will explore Byrd's early life and development, his first hits, 1970s comeback, untimely death and musical legacy.

Kunian, music curator at the New Orleans Jazz Museum, created the exhibition in 2018 to commemorate the centennial of Professor Longhair's birth on Dec. 19, 1918, in Bogalusa. The exhibit has been updated for display at Capitol Park Museum, the department said. It's titled "Me Got Fiyo: The Professor Longhair Centennial."

The museum will host a variety of programs in conjunction with the exhibition, including a "Women in the Blues" panel discussion on April 21.


The Capitol Park Museum was founded in 2007 as part of the Louisiana State Museum. It's across the park from the Capitol building and houses 500,000 artifacts that showcase the state's history and culture.

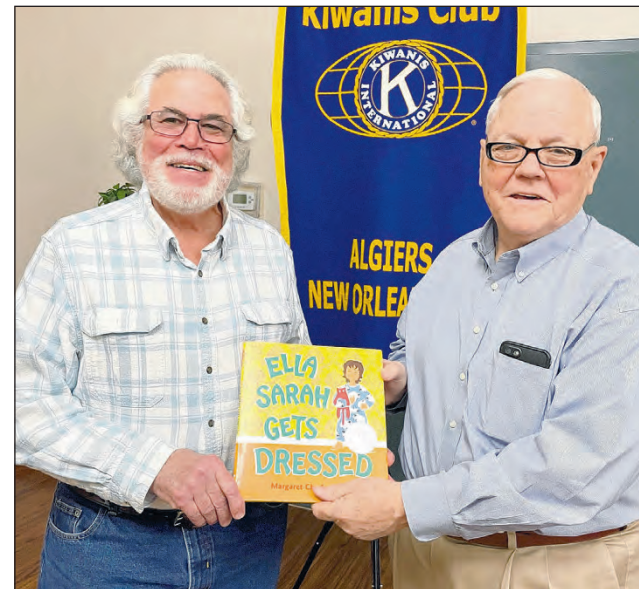

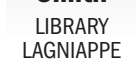

# Print books found to be keeping edge over e-books

## Jefferson Library can provide both

During the recent pandemic, library patrons across the country indulged their reading habits by using their library's online services. In other words, they checked out e-books and read them with their electronic devices.

However, a recent survey by the Pew Research Center found that print books still maintain a strong edge for readers and are likely to remain popular for quite some time.

According to the Pew survey:

- 72% of U.S. adults read a book in some format over the past year
- 65% of respondents read a book in the past 12 months
- 37% of Americans read print books
- 28% read both print books and e-books
- 7% only read e-books
- Other interesting statistics:
  - Print books outsell e-books by a 4 to 1 margin.
  - 191 million e-books were sold in the United States in 2020.
  - Printed book sales amounted to 750.89 million units in 2020.
  - Print book sales increased 13.2% between 2020 and 2021, and 21% between 2019 and 2021.
  - E-book sales grew by 22% in 2020.
  - E-book sales have decreased 8% in 2021 but are still 8% higher than they were in 2019.
  - In 2020, 19% of adult readers

owned an e-reader, a decrease from 32% of adult readers who owned e-readers in 2014.

The Jefferson Parish Library has more than 660,000 books in its 16 libraries.

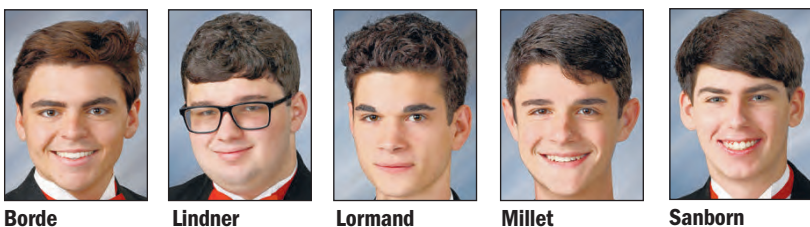

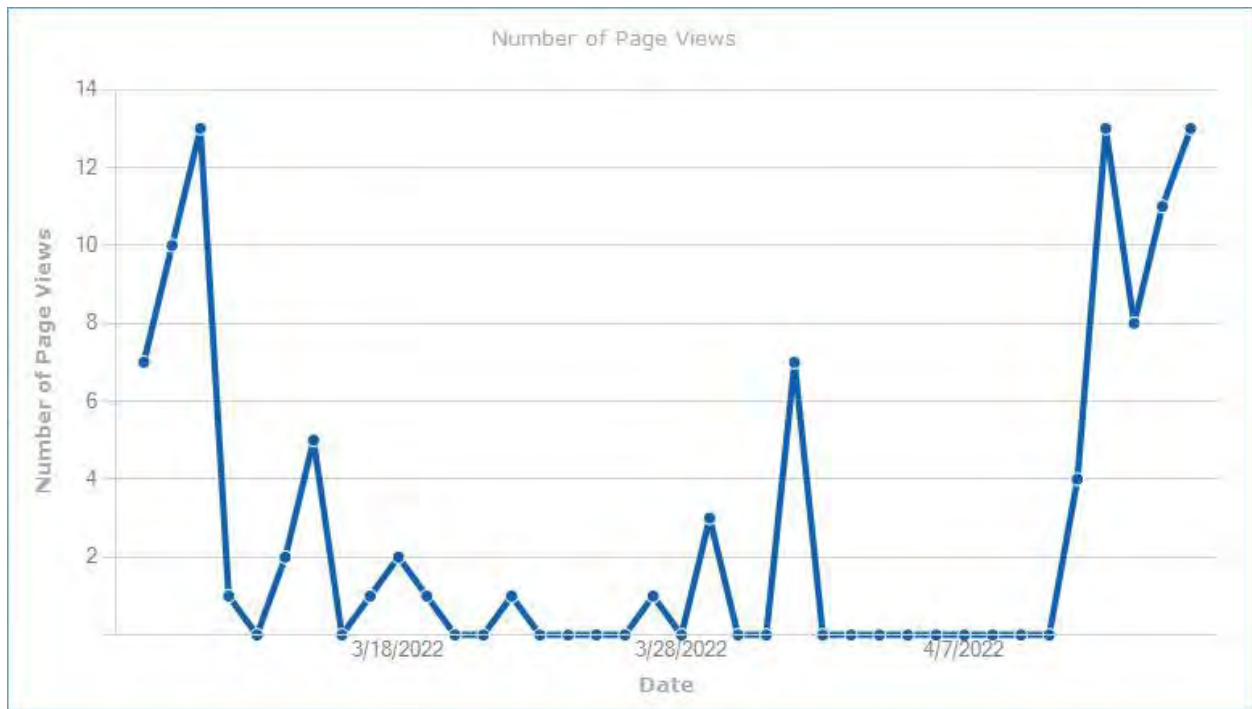

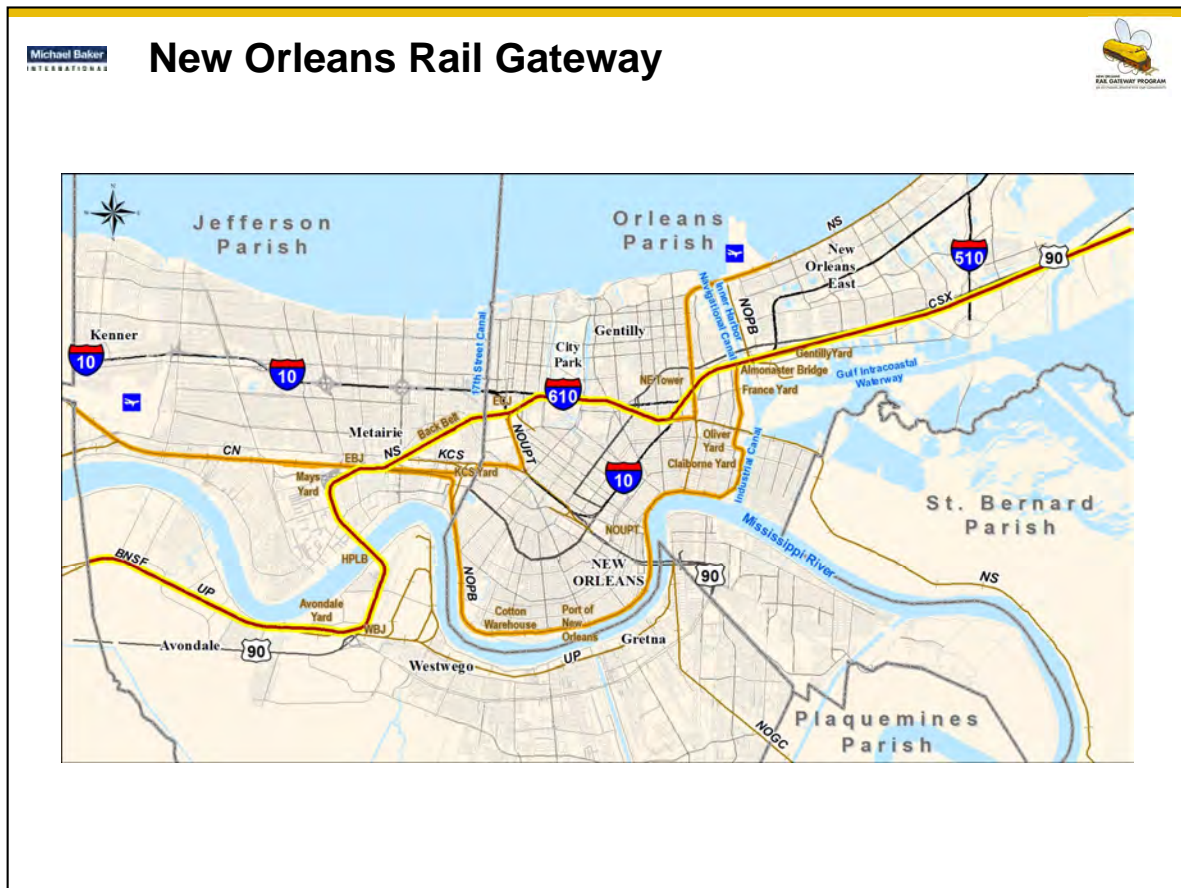

- It then proceeds through the City, through the CSX Gentilly Yard and through New Orleans East to its terminus near Industrial Parkway.

A Public Private Partnership was formed between the

- Association of American Railroads representing the six Class 1 Railroads operating in the New Orleans metropolitan area,
- New Orleans Public Belt Railroad, and

to collectively investigate possible solutions to that could reduce highway crossing delays and improve rail service.

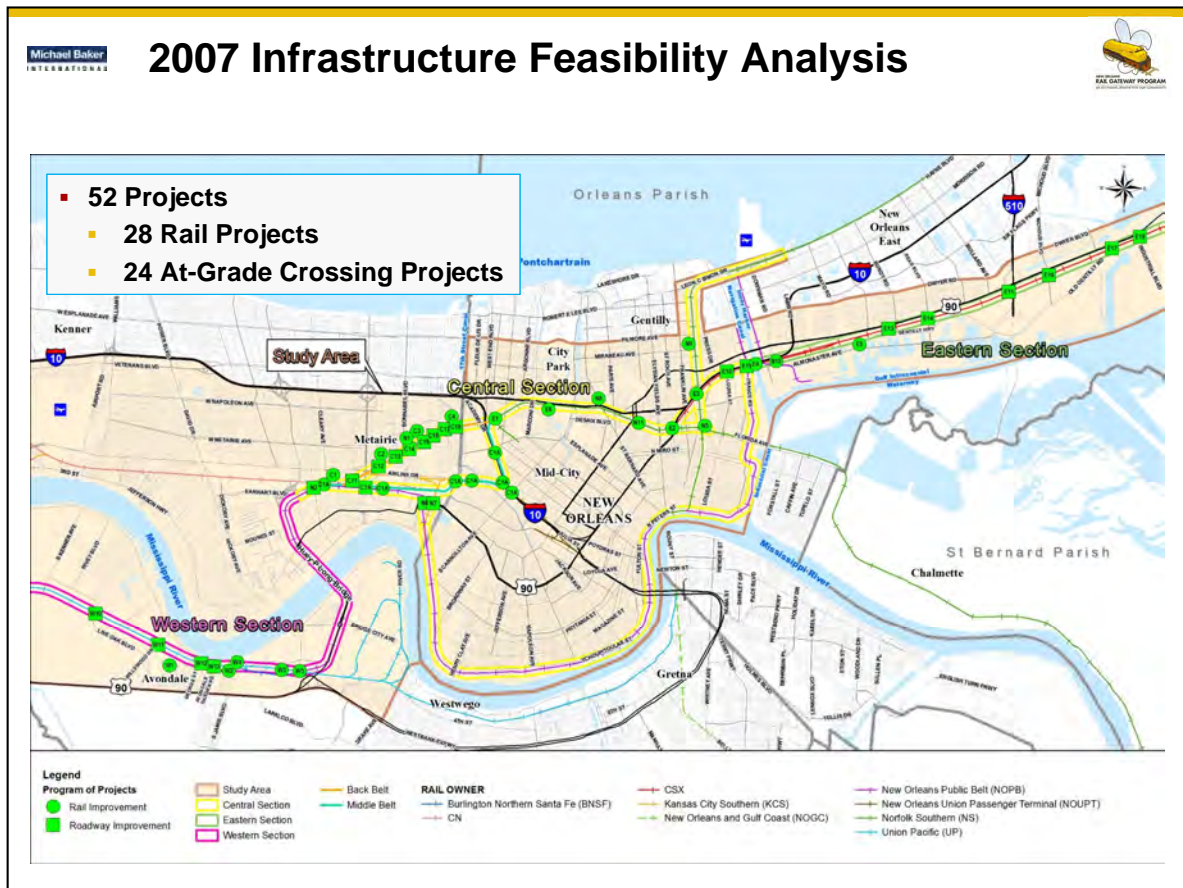

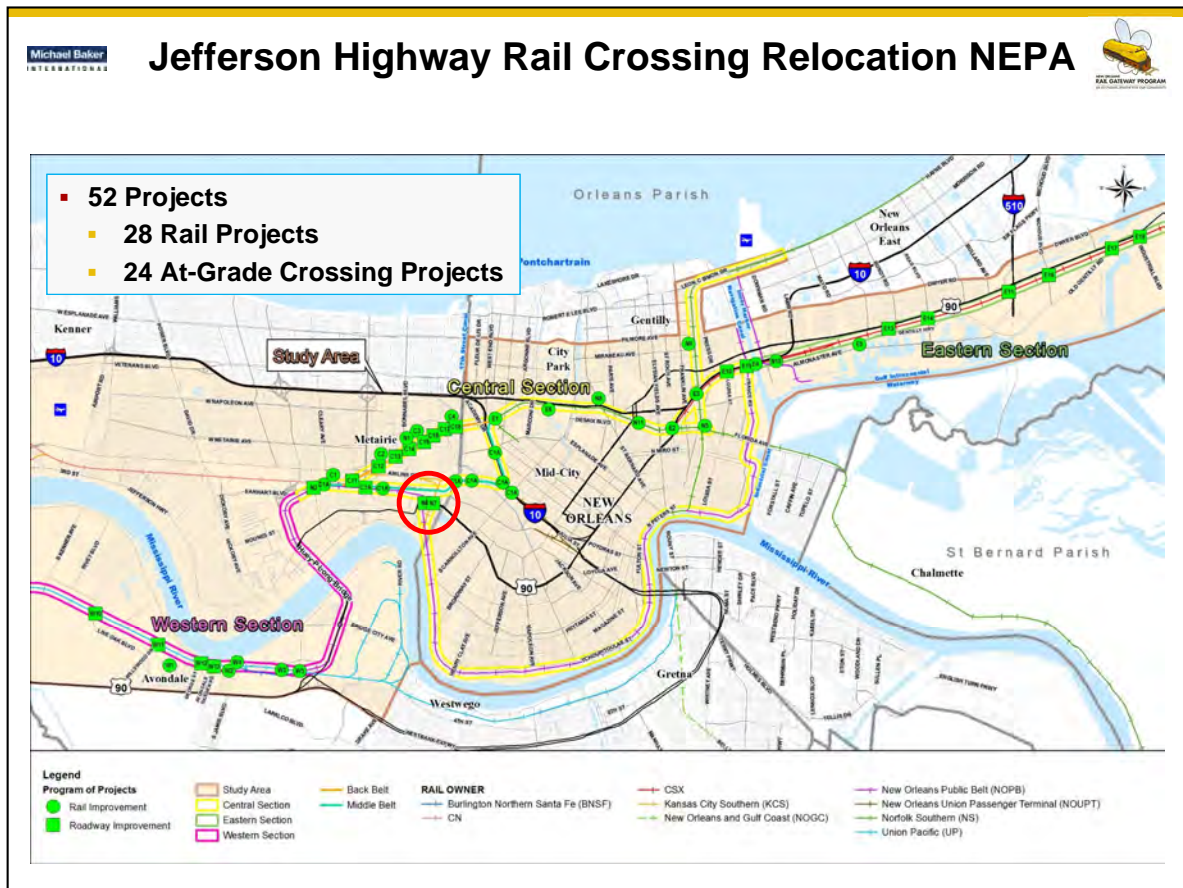
The Partnership conducted studies in 2004, 2007 and 2008.

The 2007 Infrastructure Feasibility Analysis (2007 Study) evaluated the Gateway and potential Gateway-wide rail and roadway improvements.



In all, 52 individual rail and roadway improvement projects (28 rail, 24 roadway) were identified throughout the Gateway and connecting rail lines.






Engineering and environmental studies are already underway for improvements to Jefferson Highway (US 90) in Jefferson.

## Jefferson Highway Rail Crossing Relocation NEPA



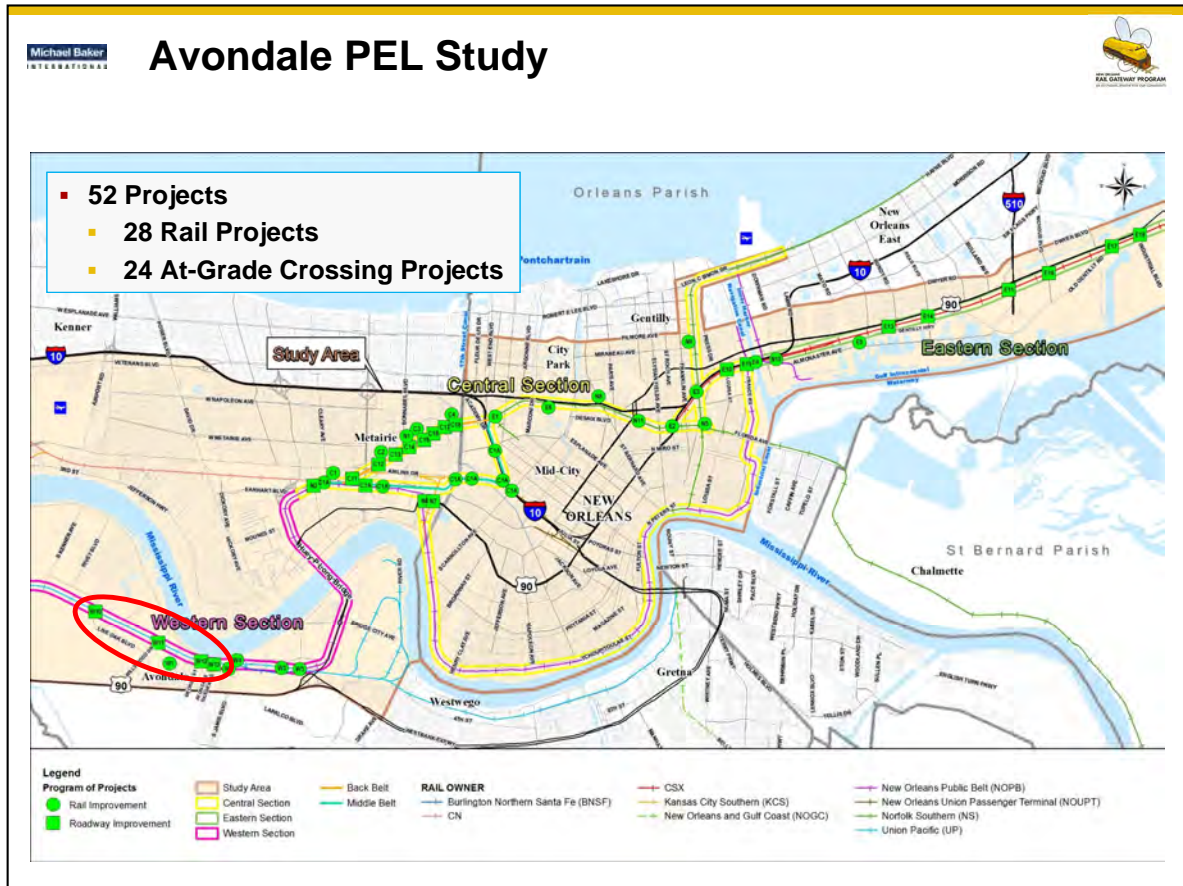

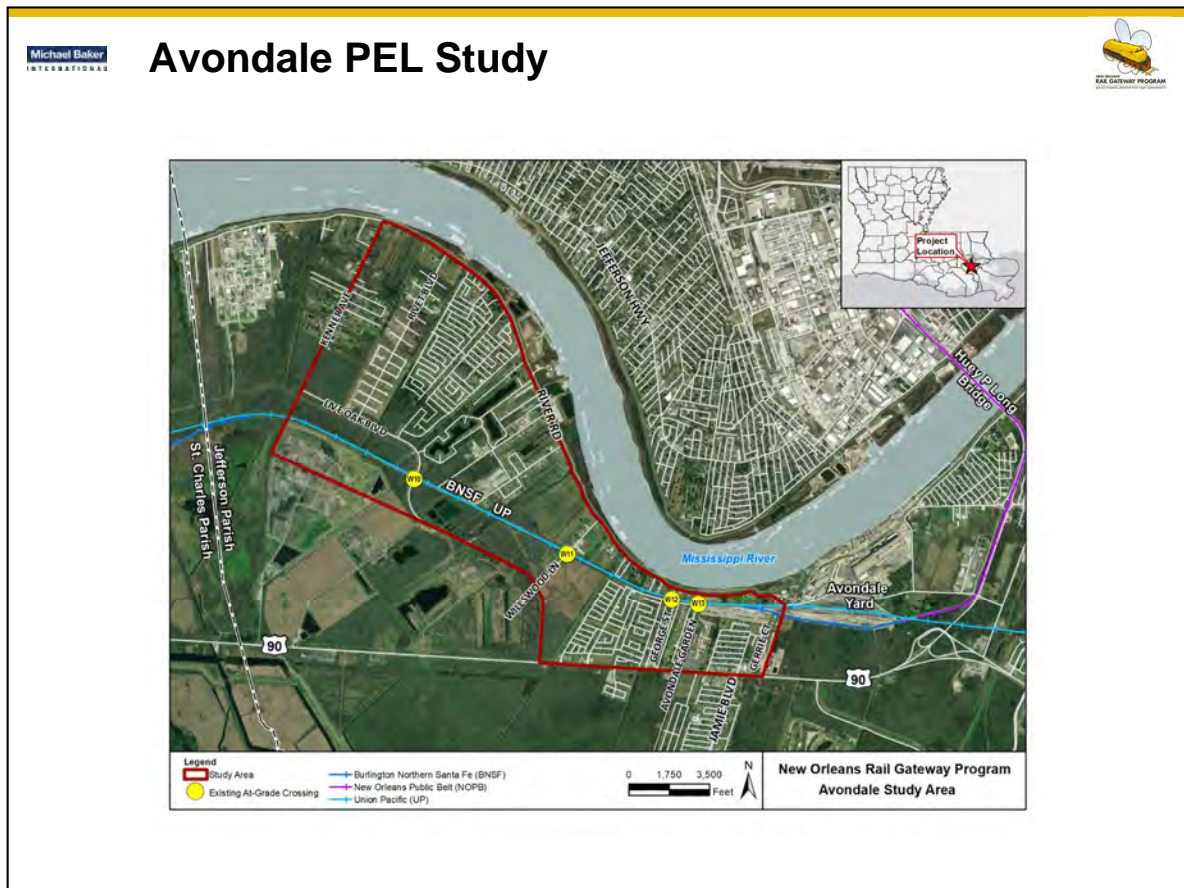
The Jefferson Highway Rail Crossing Relocation study is evaluating consolidating the two at-grade highway-rail crossings between the Ochsner Health Foundation Hospital and Monticello Avenue to a single location and possibly grade separating that consolidated rail crossing.

The study goals include:

- Reducing vehicle congestion and delay,
- Supporting hospital expansion and regional economic development
- Improving safety, and
- Increasing freight fluidity through the Gateway and the Port of New Orleans.



DOTD is initiating a similar study in the Avondale and Waggaman area.



The Avondale PEL Study will evaluate the at-grade highway-rail crossings at Live Oak Boulevard, Willswood Lane, George Street and Avondale-Garden Road.

These crossings were identified as Projects W10 through W13 in the 2007 Infrastructure Feasibility Analysis.

## Avondale Garden Road Crossing

The crossing at Avondale Garden Road increases to 6-tracks as it approaches the Avondale Rail Yard and Intermodal Terminal.


There is only one set of crossbucks, lights and gates at this crossing.





## Avondale PEL Study



- **On average, 31 freight and passenger trains cross these roadways each day**
- **Vehicle delays of possibly 10 minutes or longer for trains to clear the crossings**

- **Jefferson Transit – Avondale W1 Bus Route**

  - **Train-Vehicle Crashes (1977 – 2007) (FRA)**
    - 27 crashes (9 injury, 2 fatality)
    - No train-vehicle crashes since 2007
  - **Vehicle-Vehicle Crashes (2017 – 2019) (DOTD)**
    - 4 crashes (no injury or fatality)







On average, 31 freight and passenger trains cross these roadways each day resulting in vehicle delays of possibly 10 minutes or longer for trains to clear the crossings.

The picture at the top shows a bus crossing the tracks at George Street. At least one of the three area schools use these crossings.

Jefferson Transit's Avondale – W1 buses travel through the Kennedy Heights neighborhood with a stop at Capitol & Cathedral, but their route does not cross the tracks.

As report by the FRA, there have been 27 crashes are these four crossings since 1977, with 9 being injury and 2 being fatality crashes. There have been no other train-vehicle crashes since 2007.

DOTD crash data for the 3-year period from 2017 -2019 recorded 4 vehicle-vehicle crashes at the crossings. Vehicle to vehicle crashes are not recorded in the FRA data.



## Avondale PEL Study Goals



- **Reduce vehicle delay due to rail traffic and Avondale Rail Yard switching operations**
- **Improve safety**
- **Eliminate truck traffic from roadways posted as “No Truck Route” with a 5-Ton Limit**
- **Improve intermodal connectivity**

- Reducing vehicle delay due to rail traffic and Avondale Rail Yard switching operations,
- Improving safety,
- Eliminating truck traffic from roadways posted as “No Truck Route” with a 5-Ton Limit, and
- Improving intermodal connectivity.

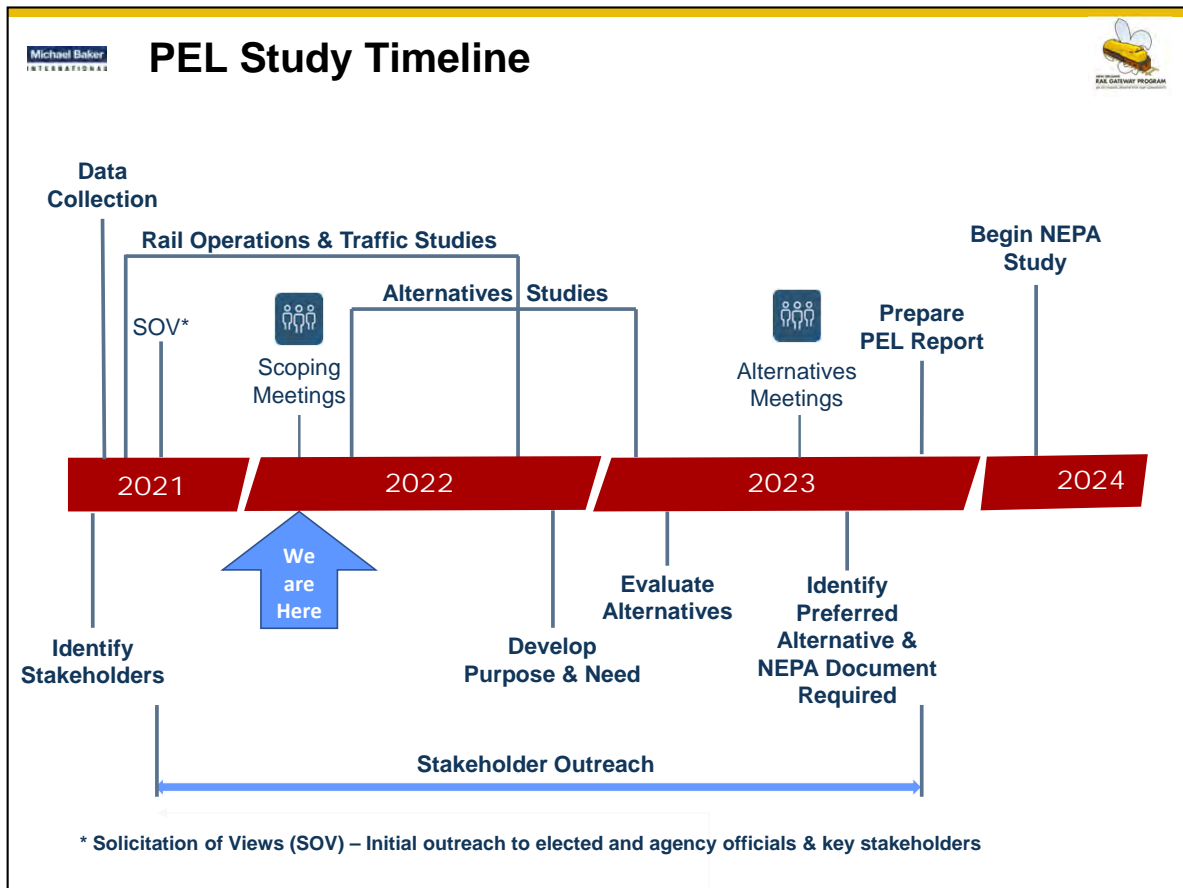

The Avondale PEL Study will evaluate the feasibility of closing these four public crossings and replacing them with one, or possibly more, overpass (road-over-rail) grade separations. A rail operations analysis, traffic and alternative studies and an environmental inventory will be performed.

The location and number of grade separation(s) will be evaluated as part of this study and presented at a future meeting.



The study is anticipated to take about 2½ years to complete. A virtual meeting, like this one, is planned for mid-2023 to present the alternatives developed and solicit comment.

U.S. Fish and Wildlife Service (USFWS)	Certain birds are protected under the Migratory Bird Treaty Act and the Bald and Golden Eagle Protection Act. The birds listed (list provided) are of particular concern because they appear on the USFWS Birds of Conservation Concern (BCC) list or warrant special attention in the project location.
Natural Resources Conservation Service (NRCS)	The proposed project area will not impact prime farmland and therefore is exempt from the rules and regulations of the Farmland Protection Policy Act (FPPA)
US Army Corps of Engineers (USACE)	The site is indicative of the occurrence of waters of the United States, including wetlands. Several potentially required permits were identified.
Louisiana State Historic Preservation Officer (SHPO)	Our office cannot offer an opinion concerning effect determination. However, we are not aware of potential concerns at this time. This opinion could change once we receive additional information concerning this project.
Louisiana Dept of Environmental Quality (LDEQ)	No objections based on the information provided. General comments provided for information.
Louisiana Dept of Wildlife & Fisheries (LDWF)	A Bald Eagle nest is located adjacent to the study area. No other impacts to rare, threatened, or endangered species or critical habitats are anticipated.
Louisiana Dept of Natural Resources (LDNR)	There are oil, gas or injection wells in the project area. The DNR water well database indicates that there are also registered water wells located in the vicinity of the project area.
Louisiana Department of Agriculture & Forestry (LDAF)	No objection or further comment at this time.
Louisiana Office of Public Health	No objection at this time.

Over 100 letters were sent to Federal-, State- and Local- officials, regulatory & resource agencies, transit agencies, and other interested parties to inform them of the study and solicit their initial comments.

Eleven responses were received from Federal-, State- and Jefferson Parish regulatory & resource agencies. Several agencies identified required permits or identified environmental resources in the area.

None indicated any objections or concerns with the project at this time.

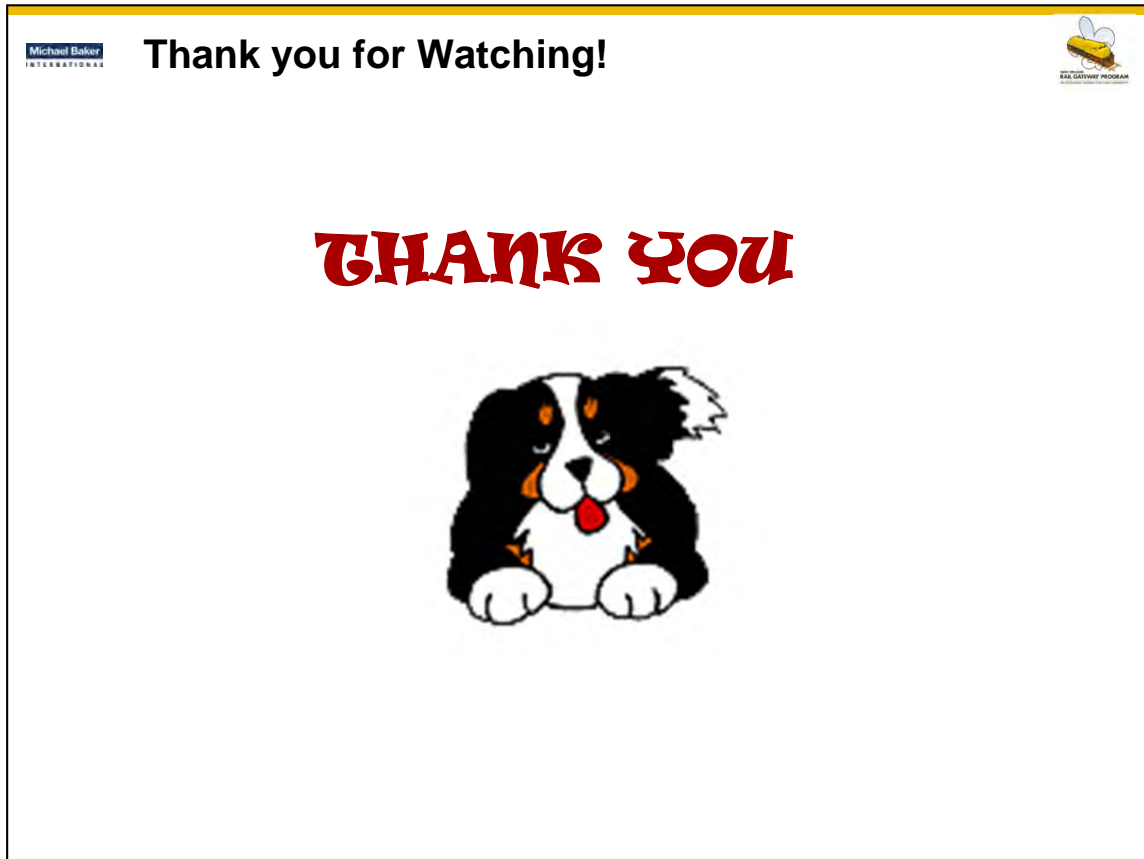

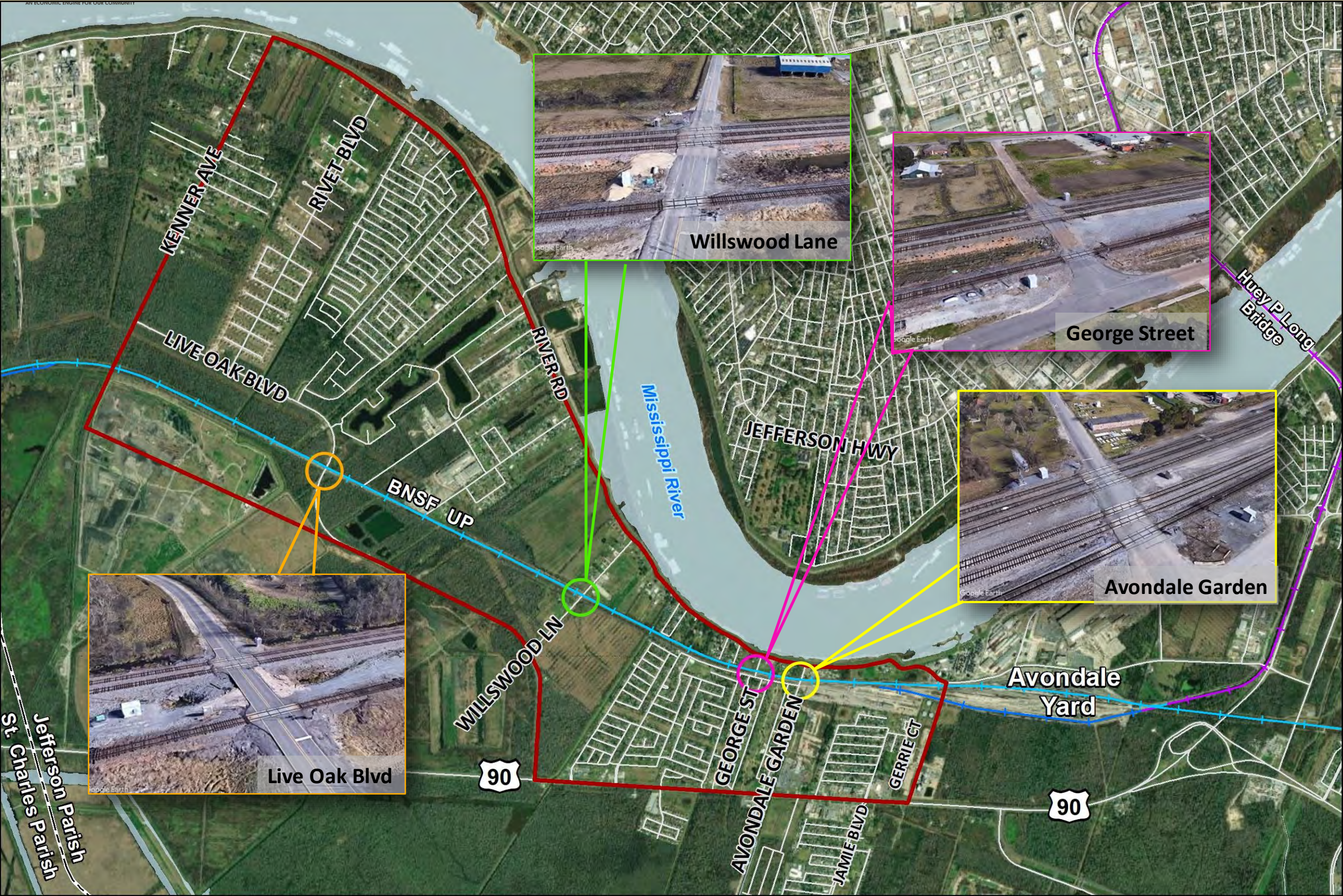

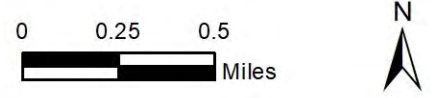
