

INTRODUCTION

- 1. R.S. 48:229.1, 230 states that "the Department shall provide the Legislature and public with this program which shall list projects to be constructed in the ensuing fiscal year"... that considers the "anticipated revenues to be appropriated by the legislature." The Department shall also provide the Legislature a list of projects "which are in various stages of planning and preparation."
- 2. In compliance with this statute, the attached Highway Program identifies the projects that are scheduled for construction letting in FY 2021-22. These are denoted as being in Stage 4. Projects being developed in the other stages are also included in the document.
- 3. There are many projects remaining to be let prior to the end of the current fiscal year, FY 2020-21. For informational purposes, these projects are also listed in this document. In the event any of these projects cannot be let as planned, they will become part of the FY 2021-22 construction program, and will be let as soon as practicable in that fiscal year.
- 4. The one year construction program and the list of other projects in various stages are combined into this document which is called the Highway Priority Program or Highway Program. These projects are also submitted to the Federal Highway Administration along with the Transit Program. The two programs together are referred to as the State Transportation Improvement Program (STIP). The Public Hearings held each year in each Highway District fulfill both the State and Federal requirements for public involvement regarding these programs.
- 5. DOTD has based this preliminary Highway Program on anticipated revenues. If funding above the expected amount is made available, funding may be used on projects listed in Stages 0, 1, 2, or 3.
- 6. In the event all of the projects listed for letting in FY 2021-22 cannot be let to construction due to funding issues or unforeseen problems encountered in the pre-construction process, the affected project(s) will be let as soon as practicable in the following year and other projects listed in Stages 0, 1, 2, or 3 may be advanced into FY 2021-22.
- 7. Construction estimates are for informational purposes only and are subject to change.

Statewide prioritization process for the Highway Priority Program beginning FY2017-2018

According to Louisiana Revised Statute 48:229.1.A the construction projects included in the Highway Priority Program should accomplish the following:

Goal 1: Preserve/Sustain the System

(1) Brings the state highway system into a good state of repair and optimizes the usage and efficiency of existing transportation facilities. *Prospective Outcome 3.1.1, 3.1.2, 3.1.3, 3.1.4, 3.1.5, 3.1.6, 3.2.1*

Goal 2: Operate the System

- (3) Supports resiliency in the transportation system, including safe evacuation of populations when necessitated by catastrophic events such as hurricanes and floods. *Prospective Outcome 3.2.1*
- (7) Encourages innovation and the use of technology. Prospective Outcome 3.2.1

Goal 3: Improve the Safety of the System

(2) Improves safety for motorized and non-motorized highway users and communities. *Prospective Outcome 3.2.1, 3.2.2, 3.2.3*

Goal 4: Expand the System

- (4) Increases accessibility for people, goods, and services. *Prospective Outcome 3.2.1, 3.2.5, 3.2.6*
- (5) Fosters diverse economic development and job growth, international and domestic commerce, and tourism. *Prospective Outcome 3.2.1, 3.2.5, 3.2.6*

Goal 5: Improve Quality of Life

- (6) Fosters multimodalism, promotes a variety of transportation and travel options, and encourages intermodal connectivity. *Prospective Outcome 3.2.1*
- (8) Protects the environment, reduces emissions, and improves public health and quality of life. *Prospective Outcome 3.2.1*

Per R.S. 48:229.1.C, the following factors must be considered when selecting projects for inclusion in the Highway Priority Program:

- (1) The condition of the roads, streets, and structures making up the state highway system and the relative urgency of the improvements considering in their order of general needs.
- (2) The type and volume of traffic on a particular segment of roadway, highway, or bridge.
- (3) The crash records for a particular segment of roadway, highway, or bridge.
- (4) The technical difficulties in the preparation of plans and the procurement of rights-of-way for a particular segment of roadway, highway, or bridge.
- (5) Whether unforeseeable emergencies such as floods have created an immediate need for improvement or reconstruction.
- (6) Whether capacity improvements are warranted due to population or traffic volume increases in specific geographic areas.
- (7) Whether or not the highway or bridge is or will be on an evacuation route utilized to evacuate large populations due to catastrophic events such as hurricanes or flooding.
- (8) Whether the improvement to or addition of a highway or bridge will benefit the economic development potential of the state.

In accordance with R.S. 48:229.1.D, projects must be screened to determine whether they are consistent with the most recent Statewide Transportation Plan and warrant inclusion in the Program.

Per R.S. 48:229.1.F, the Department shall identify and report prospective outcomes of each program. The Department shall evaluate the actual outcomes of each program and establish revised prospective outcomes of each program on a biennial basis.
